Psychosomatics, psychosomatic illness and psychosomatic medicine - it ishard to find anyone today who has not heard of it.Most people will answercorrectly that these terms have something to do with the "body-mindproblem" which has been known to exist for centuries and investigated bynumerous scientists from the most varied disciplines. However, outside theworld of experts only a few people are aware of the complexity of interactions betweenpsychological and physical processes. However, in spite of theintensive work pursued world-wide, many questions are still unanswered. Welcoming Messages

Dear Colleagues, Fifty years after the first conference, the 25th European Conference of Psychosomatic Research 2004 will take place in Berlin,in the heart of Europe. The German College of Psychosomatic Medicine is proud to host this renowned international meeting of European psychosomatic re-searchers. Our aim is to discuss new perspectives in the development, maintenance and treatment of diseases with an emphasis on biological, psychological and social aspects. We are aware of the fact that this type ofpsychosomatic or behavioral medical research is not possible without thecooperation of physicians psychologists, sociologists, and others, in aninterdisciplinary network. This conference will thus promote an intensivescientific exchange of many professional groups on all levels. We are committed not only to a high scientific standard but also to excellent medical care. We attach importance to the scientific testing of psychotherapeutic treatment methods, which is an integral component ofpsychosocial care, especially here in Germany. This conference will therefore focus on differential indications as well as psychotherapeutic treatmentmethods in the short-term and long-term perspective. The position of psychosomatic medicine is very different across European countries. This reflects the different intellectual traditions and historical experiences. The advantage of publishing onlywell-founded studies with scientifically sound results as judged by peer review carries also adisadvantage. Only those studies which have been performed in a methodologically adequatemanner can be included. This means that several complex factors tend to be excluded: doctor-patient behaviour and relationships, the interaction of emotional and unconscious aspects in theinteraction between patients and health professionals.Reviewing the abstracts submitted to the scientific board of the 25th ECPR, one is left with theimpression of a wide variety of new research:examining the psychosomatic basis of emotion,cognition,memory and adaptive central processes. Further, the perspective gained from researchon vegetative, hormonal and immunological phenomena at the cell and receptor level andmolecular genetic research. Territory more familiar to clinicians needs to be further developed andexpanded: the involvement of psychosocial factors in coronary heart disease or the developmentand preventive measures of infarction have greatly increased our knowledge about these diseases. There are other areas of research highlighted in the wide variety of scientific work:essential hypertension.bronchial asthma and colitis,irritable bowel syndrome as well asfibromyalgia, eating disorders, metabolic syndrome/diabetes, pain, and psycho-oncology. Stressresearch has relied upon the experience of catastrophic events and wars. Beside well-known social constructs, such as social support, new constructs like attachment have gained great importance. Gender research, life span and geriatric psychosomatic studies are other areas which are nowrightly receiving great attention.

We have invited a number of renowned researchers from Europe and other countries who willensure an attractive and interesting program. The conference and the social activities programoffer an excellent opportunity to explore Berlin and its surrounding countryside, experience theculture and history of Germany, and enjoy the beautyful march of Brandenburg with its castles, forests and lakes. Formerly at the center of the East-West conflict, it is now possible to witness howthe Eastern and Western parts of the city have grown together after the fall of the wall. We hope that you will enjoy a few interesting days in this dynamic European metropole and leavethis conference with new knowledge and insights. We welcome you in Berlin!
